#### **RESOLUTION NO. 2016-R-05**

### A RESOLUTION APPROVING THE INCLUSION OF A MULTI-COUNTY BUSINESS PARK FOR PROJECT DECK INSIDE THE CITY LIMITS OF THE CITY OF WALTERBORO

WHEREAS, the City of Walterboro, South Carolina (the "City"), acting by and through its City Council (the "City Council") is authorized and empowered under and pursuant to the provisions of Section 4-1-170 of the Code of Laws of South Carolina 1976, as amended, and Article VIII, Section 13 of the South Carolina Constitution (collectively, the "Multi-County Park Law") to consent to the creation of a multi-county business park (the "Park") within its municipal boundaries, through which powers the industrial development of the State of South Carolina and the City will be promoted and trade developed by inducing manufacturing and commercial enterprises to locate and remain in the State of South Carolina and the City and thus to utilize and employ the manpower, products, and natural resources of the State of South Carolina to benefit the general public welfare of the City by providing services, employment, and other public benefits not otherwise provided locally; and

WHEREAS, Project Deck and/or its subsidiaries, affiliates, successors, assigns, sponsors, lessors, and others (collectively, the "Company"), desire to invest capital in the City in order to construct and operate a manufacturing facility on an approximately 4.7 acre tract of land located on Mable T. Willis Boulevard, in the City (the "Tract") (the "Project"); and

WHEREAS, the Project is anticipated to result in an investment of over \$1,000,000 over a fiveyear period and the creation of new jobs; and

WHEREAS, the City has offered to consent to the creation of the Park within its boundaries encompassing the Project and the granting of special source revenue credits ("SSRC") as described in the SSRC Agreement between Colleton County, South Carolina (the "County") and the Company (the "SSRC Agreement"), with respect to all of the FILOT payments made by Company as a result of the inclusion of the Project in the Park, subject to the County agreeing to distribute to the City the City's pro rata share of the FILOT Payments after application of the SSRC to the City.

WHEREAS, the City has determined that the Project would serve the purposes of economic development within the City;

WHEREAS, the City has also determined, after an appropriate cost-benefit analysis that, in order to induce the Company to locate the Project in the City, it desires to provide the incentives described herein.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Walterboro, South Carolina:

Section 1. The City Council hereby finds that: (i) the Project is anticipated to benefit the general public welfare of the City by providing services, employment, recreation, or other public benefits not otherwise adequately provided locally; (ii) the Project gives rise to no pecuniary liability of the City or a charge against its general credit or taxing power; (iii) the purposes to be accomplished by the Project are proper governmental and public purposes and the inducement of the location of the Project within South Carolina is of paramount importance and the benefits of the Project to the public are greater than the cost; and (iv) it has evaluated the Project considering all relevant and required factors, including, but not limited to, the anticipated dollar amount and nature of the investment to be made and the anticipated costs and benefits to the City, and all other criteria prescribed by law.

- Section 2. The City hereby agrees to the creation of the Park on the Tract within its boundaries, provided that the FILOT Payments are distributed pro rata to all taxing entities after application of the SSRC described in the SSRC Agreement between the County and the Company.
- Section 3. To the extent this resolution contains provisions that conflict with other orders, resolutions, and parts thereof, the provisions contained in this resolution supersede all other orders, resolutions and part thereof and this resolution is controlling.
