MINUTES

A Public Hearing and Regular Meeting of Walterboro City Council was held at City Hall on Tuesday, March 24, 2015 at 6:15 P.M., with Mayor Bill Young presiding.

PRESENT WERE: Mayor Bill Young, Council Members: Jimmy Syfrett, Paul Siegel, Tom Lohr, Bobby Bonds, James Broderick and Judy Bridge. City Manager Jeff Molinari, City Clerk Betty Hudson and City Attorney George Cone were also present. There were approximately 17 persons present in the audience.

There being a quorum present, Mayor Young called the meeting to order and welcomed everyone to the meeting. He gave a special welcome to members of the Leadership Colleton Class. Council Member Syfrett gave the invocation and Council Member Bridge led the pledge of allegiance to our flag.

PUBLIC INPUT ON AGENDA ITEMS:

There were no public comments or questions on agenda items.

PUBLIC HEARING:

The Mayor then opened a public hearing, duly advertised, to receive public comments and questions on proposed Ordinance # 2015-01, An Ordinance to Amend the Unified Development Ordinance of the City of Walterboro, So As to Clarify and Strengthen Portions of the Ordinance.

City Manager Molinari told Council that the Planning and Codes Director David Dodd would give a brief summary of this ordinance. He also explained that the majority of items in this ordinance revision are cosmetic and clean up some of the verbiage. The most substantive item in the proposed revision deals with the maximum height of structures in the Interstate Interchange Commercial District. It takes the maximum height to 68 feet and a maximum of 5 stories.

Planning Director David Dodd said that pretty much covers it. Most of the changes refers to definitions, mis-numbered sections and page numbers, in addition to that change for the height and number of stories. That is in order to allow larger hotel development in that area.

Mayor Young then asked for any comments or questions from the public. None were given.

The Mayor then asked Mr. Dodd, I guess it is public knowledge as to the kind of hotel that we are going to get out there. People might be interested in knowing that.

Mr. Dodd stated that the City had received an inquiry from Hampton Inn, in order to build a new Hampton Inn, and they would rebrand the old two story. The Mayor said, it would be a Hampton Inn and Suites, is that right? Mr. Dodd answered affirmatively.
