MINUTES

A Regular Meeting of Walterboro City Council was held at City Hall on Tuesday, October 28, 2014 at 6:15 P.M., with Mayor Bill Young presiding.

PRESENT WERE: Mayor Bill Young, Council Members: Jimmy Syfrett, Paul Siegel, Tom Lohr, Bobby Bonds, James Broderick and Judy Bridge. City Manager Jeff Molinari, City Clerk Betty Hudson and City Attorney George Cone, along with Attorney Matthew Gates, were also present. Attorney Gates is a new attorney with the McLeod, Fraser and Cone Law Firm. There were approximately 14 persons present in the audience.

There being a quorum present, Mayor Young called the meeting to order and welcomed everyone to the meeting. Council Member Syfrett gave the invocation, and Council Member Broderick led the pledge of allegiance to our flag.

PUBLIC INPUT ON AGENDA ITEMS:

There were no public comments or questions on agenda items.

APPROVAL OF MINUTES:

The Minutes of the October 14, 2014 Regular Meeting were approved as submitted upon motion of Council Member Bridge, seconded by Council Member Broderick, with all members voting in favor.

OLD BUSINESS:

There was no Old Business before Council.

NEW BUSINESS:

1. <u>Consideration of Funding Recommendations from the Accommodations Tax</u> <u>Advisory Board</u>

The City Finance Office Manager, Ms. Amy Risher, reported to Council that the A-Tax Board met on October 16, 2014 and approved the following funding requests:

Ms. Risher told Council that should the requests be approved, the projected remaining balance available for 2014-2015 grants is approximately \$31,620. She also announced that the board will hold a meeting in February 2015 and anticipates additional funding requests at that time.

A motion was made by Council Member Lohr, seconded by Council Member Bonds, to accept the recommendations for funding by the A-Tax Board as submitted. The motion passed unanimously.

2. <u>Consideration of Recommendation to Purchase Three (3) Vehicles for the Police</u> Department

City Manager Molinari informed Council that in the 2014-2015 budget, City Council allocated \$132,600 for the purchase of new police vehicles. He then stated that he has asked Police Chief Wade Marvin to give Council an overview of the vehicle request.

Police Chief Wade Marvin then addressed Council. He told Council that three bids were received for the purchase of the three police vehicles as follows:

Rizer Chevrolet - 2015 Chevrolet Caprice police package No bid
Walterboro Ford - 2015 Ford Interceptor police package \$112,877.93
Butler Dodge - 2014 Dodge Charger police package \$108,558.93

Chief Marvin pointed out that Butler Dodge holds the State Contract for the police package on the Dodge Charger. Chief Marvin also explained that this month (October) is the cut-off date for state purchase. Every car would have to be resubmitted through the state when the cut-off date comes. So, if you don't get your bids in by October 31, then by Nov 1 the price rises, and this usually averages between \$700 to \$800 per car. He stated that Butler Dodge has the vehicles on their lot already, because they provide Dodges for the whole entire state. Colleton County just purchased some vehicles from them. Mr. Marvin also explained that Butler told him they would discount the state purchase price as well, and knock off an additional \$800 from the price of each car because they have them in stock and they know that 2015 is coming up. The difference between the 2014 and 2015 cars is really nothing. You might have an automatic up or down window. At the very minimum, the vehicle itself is not going to change from a 2014 to 2015 for the Interceptor or for the Dodge.

Chief Marvin told Council that the Butler Dodge's vehicle was cheaper every way he looked at it, whether it included the 3 percent local preference or not. The fact that the Butler Dodge gave us the state purchase price and an additional discount, moves them ahead of the other bidders. He reported that he had talked with several other police agencies - The City of Charleston goes with the V-6 model. He also stated that Dodge Chargers are a little roomier and the police officers love them. They handle well. It has a 0-36,000 miles warranty. After that, I spoke with Gerald's automotive, who does our routine maintenance, and he did not have an issue with working on a Dodge. We have two Dodge trucks in our fleet now.

In conclusion, Chief Marvin stated we would be saving tax dollars for the citizens if we go with the Dodge Charger and the fact that we can immediately put them into service.

Council Member Broderick then asked about the maintenance on the vehicles. He asked if any of the warranty work were needed, would it be done in Beaufort or could we do the warranty work here? Mr. Marvin responded yes, it depends on what it is. If the windshield wiper motor goes out, Gerald's can do it, and then they send it to them, and they reimburse them in some kind of way. At the county in the past, if it was something minor, a lot of time they would run it to Beaufort and if it was major, they would run it to Beaufort as well.

Council Member Bridge then asked if the bid total was the price for the cars regardless of whether it is purchased by the end of October or not? Do you have to go through the process all over again for submitting bids? Mr. Marvin explained that he would not have to rebid a 2015 vehicle but would have to redo the 2014 vehicle bids. He also explained that the Chevrolets come from Australia, and the Fords come

from somewhere else in the country, and they have not even started making the 2015 Ford Interceptor yet. So, it's at least 10 or possibly 16 weeks out.

Mayor Young then asked, would the fact that one is a 2014 and one is a 2015 vehicle account for the difference in the prices? Mr. Marvin responded, I think that's a little to do with it, but the fact that the Dodge came off with a discount of another \$700 or \$800 off the 2014 - that's where the biggest price difference is because of the additional discount.

Council Member Siegel then asked, after a bid is made, do you continue the negotiation? Mr. Marvin answered affirmatively. Mr. Siegel then asked, so that \$800 discount was in the original bid? Mr. Marvin responded, yes.

Mayor then asked what was the difference even when you considered the local preference? Mr. Marvin responded, with the local preference, they were still less. It was \$632.60 higher with the 3% preference. Mayor Young then said, so even when you apply the local preference to the local bid, does it still come in higher? Mr. Marvin responded, yes it does at about \$632.60. Mayor then added, but it is a year newer car.

Council Member Siegel then asked Chief Marvin, do you prefer the Dodge over the Ford, not withstanding the delay and delivery? Mr. Marvin responded, I don't personally, I don't have a preference. But the general consensus of this Dodge Charger - back in the day did not make a V6 model, only a V8. For a city to purchase one, it was not really recommended. But with the new V6 model over the last few years, Charleston City and Charleston County have had these vehicles and have really loved them. They say they are roomier. I called Chief Woods at Charleston County and spoke with him and a few other departments, and they all said the Dodge was roomier. It performs and handles really well. Chief Marvin also stated that the Michigan State Police has a test with all police vehicles. Anything you buy which is at the state purchase price, they do a test on it, and it (the Dodge Charger) is highly recommended in the Michigan State Police Test as well. So, it is a morale thing, the guys get to see a different car, they get a new car, and it's well liked by the police officers and it is cheaper.

Mayor Young then asked why Butler Dodge bid 2015 Chargers instead of 2014 Chargers. Is it just because they had the vehicles on the lot? Mr. Marvin, yes, because they were right there, and Ford gave us a 2015 bid, but they were guesstimating that the price was going to go up \$780. Mayor Young then asked, is the Ford bid a state contract bid? Chief Marvin responded, No, not for Walterboro Ford. He added, if you don't have that state purchase contract, it is extremely hard for anybody to meet it. For example, Love Chevrolet in Columbia has the Chevrolet state purchase price, and it is extremely hard for Mr. Rizer to come close. Mayor Young then said, I know in the past he has met state contract price on a lot of vehicles we purchased from him. Mr. Marvin responded, his bid came in late and it was around \$3,000 more than the state purchase price.

A motion was made by Council Member Bonds, seconded by Council Member Broderick to approve the recommendation to accept the bid to purchase two police vehicles from Butler Dodge in the amount of \$108,558.93. The motion passed with all members voting in favor.

3. Request to Close Church Street between Fishburne Street and Miller Street for Fall Picnic and Cake Walk on Sunday, November 23, 2014 from 9:00 A.M. to 2:30 P.M. by Historical and Preservation Society

Dr. Sarah Miller was present on behalf of the Historical and Preservation Society. She told Council closing the street was for safety reasons.

There were 16 persons present in the audience.

There being a quorum present, Mayor Young called the meeting to order and Council Member Syfrett gave the invocation, and Council Member Bonds led the pledge of allegiance to our flag.

The Mayor announced that Mayor Pro-Tem Tom Lohr was ill and unable to attend the meeting tonight.

PUBLIC INPUT ON AGENDA ITEMS:

There were no comments or questions on agenda items.

APPROVAL OF MINUTES:

There were no Minutes before Council for approval.

OLD BUSINESS:

There was no Old Business before Council.

NEW BUSINESS:

 Consideration of State Issued Certificate of Franchise Authority - Comcast Cable Communications Management, LLC

City Manager Molinari explained to Council that documentation in your packet had been received from the Secretary of State's office. Basically, the City's Franchise Agreement with Comcast Cable expired in June 2014. In 2006, the State Legislature passed a law which basically prohibits municipalities from negotiating their own franchise agreements with cable providers. Mr. Molinari explained that the City's franchise agreement with Comcast which expired in June 2014, was an elaborate, involved document that was done back in 2004 that the City spent considerable time negotiating. Basically, what the new law has done, is to simplify the process. As you see in your packets, it is a very simple form that would have to sent back to the Secretary of State's office. We are currently charging Comcast a 5% franchise fee, which is the maximum allowable by State law, which is assessed on gross revenues for Comcast. We also are provided by Comcast, one public access channel. That was something negotiated in the previous franchise agreement. Mr. Molinari then asked for City Council's favorable consideration.

Council Member Siegel then asked the City Manager, does this mean that we will be stuck with our 2004 contract forever?

City Manager Molinari responded, actually what it means is yes and no. We will continue to receive the 5% franchise fee and Comcast will continue to provide us with one public access channel, but all the other elements of the franchise agreement that

were negotiated back in 2004 - those are essentially gone and we are operating under a new set of guidelines - a much more basic and simplified set of guidelines.

A motion was then made by Council Member Bridge, seconded by Council Member Broderick to approve the State Issued Certificate of Franchise Authority for Comcast Cable Communications.

In discussing the motion, Mayor Young said, in the past sometimes when were negotiating franchises, we had the ability to talk to them about which stations would be offered and try to address citizens' requests on those things. We pretty much have no ability to do that anymore. The FCC has taken that away from municipalities.

The motion then passed with all members voting in favor, except Council Member Lohr was absent and did not vote.

2. <u>Consideration of Lease Proposals for a 2015 Freightliner Garbage Truck</u> \$204,957.00

City Manager Molinari told Council that the Finance Office solicited bids from seven (7) local financial institutions and received three (3) as follows:

Mr. Molinari requested Council's favorable consideration of BB&T to finance the purchase of a 2015 Freightliner sanitation vehicle at an APR of 1.61% for a term of 5 years. He pointed out that the 1.61% APR was slightly lower than what is in the budget. We factored in 1.7% for financing this sanitation truck, and this proposal came in a littler lower.

Mayor Young then asked the City Manager if Council needed to address both the Consideration of Lease Proposals and the Resolution approving the Financing Terms for the Garbage Truck as separate items? City Manager Molinari responded that they could be considered together.

A motion was then made by Council Member Siegel, seconded by Council Member Bonds to:

- 1) Approve the low bid of 1.61% by BB&T for purchase of a 2015 Freightliner Garbage Truck in the amount of \$204,957.00 and
- 2) Approve Resolution # 2014-R-10, Approving the Financing Terms for the 2015 Garbage Truck.

The motion passed with a vote of 5/0 with Council Members Syfrett, Siegel, Bonds, Broderick and Bridge voting in favor. Mayor Young recused himself from voting due to the fact that he has a relationship with BB&T. Council Member Lohr was absent and did not vote.

ORDINANCE # 2014-10

AN ORDINANCE AMENDING SECTION 12-9 AND SECTION 12-13 OF THE CODE OF ORDINANCES OF THE CITY OF WALTERBORO TO CHANGE THE DATE FOR HOLDING MUNICIPAL ELECTIONS.

WHEREAS, S.C. Code §5-15-50 provides that the time for holding general elections shall be set by ordinance; and

WHEREAS, the City of Walterboro currently holds general elections on the fourth Tuesday in May in odd-numbered years; and

WHEREAS, it is desired that the nonpartisan election date be changed to promote voter turnout and support uniformity of municipal elections in South Carolina;

NOW, THEREFORE, BE IT ORDAINED by the Mayor and Council of the City of Walterboro, South Carolina, that Section 12-9 and Section 12-13 (c) of the Code of Ordinances be amended to read as follows:

Sec. 12-9. Date.

All regular City Council elections for Mayor and Councilmembers shall be held on the first Tuesday following the first Monday in November in each odd-numbered year.

Sec. 12-13. Electors to be qualified; assuming office.
