MINUTES

A Regular Meeting of City Council and a Joint Meeting with Colleton County Council was held at City Hall on Tuesday, September 24, 2013 at 6:15 P.M., with Mayor Bill Young presiding.

PRESENT WERE: Mayor Bill Young, Council Members: Jimmy Syfrett, Paul Siegel, Tom Lohr, Bobby Bonds and James Broderick. (NOTE: Vacant seat remains due to passing of Councilman Randy Peters). City Manager Jeff Lord, City Clerk Betty Hudson and City Attorney George Cone were also present for the City. County Council Members present were: Council Members Steve Murdaugh, Gene Whetsell, Dr. Joseph Flowers, and Phillip Taylor (Chairman). County Council Member Evon Robinson was absent. County Administrator Kevin Griffin, County Administrative Services Director Dennis Averkin and Clerk to County Council Ruth Mayer were also present. There were approximately 31 persons present in the audience.

There being a quorum present, Mayor Young called the meeting to order and recognized that candidates for City Council were present at the meeting - Tony Hamilton, Mack Thomas and Judy Bridge. He then gave the invocation, and Council Member Broderick led the pledge of allegiance to our flag.

The Mayor announced that we are glad to have our County Council Members present tonight. Of course, we will be having a joint meeting with them at the conclusion of this meeting tonight.

PUBLIC INPUT ON AGENDA ITEMS:

Former Mayor Charlie Sweat, a city resident, told Council that he wanted to address agenda item No. 3, "Consideration of Purchasing 100 South Jefferies Boulevard with HUD Grant Received for Great Swamp Sanctuary Discovery Center and Associated Streetscape." He said, having been on Council for a long time and having worked with the Great Swamp Sanctuary, now known as the Walterboro Wildlife Sanctuary, I think the purchasing of this property (the Carter building) is a remarkable improvement over where we started to build for many years. It costs considerably less than the four million dollars for the Interpretive Center that is scheduled for the Sanctuary. I think this would be a marked improvement, and I encourage Council to vote to purchase it.

No further comments or questions were received.

City Manager Lord explained that in the original budget, there was a Tax Credit Factor of .001900. We have updated this and received additional information on the Local Option Sales Tax for last year which changes the calculation. So, the correct credit factor is .001506.

A motion was made by Council Member Bonds, seconded by Council Member Broderick giving First Reading Approval to Ordinance # 2013-10 as submitted. The motion passed unanimously.

 Resolution # 2013-R-09, A Resolution Authorizing the City Manager and City Clerk to Execute Forms Pursuant to USDA Facilities Grant Application in the Amount of \$50,000 for Walterboro Public Safety Radio System Replacement.

A motion was made by Council Member Siegel, seconded by Council Member Lohr to adopt Resolution # 2013-R-09 as submitted. The motion passed with all members voting in favor. A copy of said resolution is attached as part of these minutes.

The Mayor then recognized that Ms. Nicky Toomes of the local USDA Rural Development Office was present tonight. Ms. Toomes is responsible for helping the City to receive this grant. Ms. Toomes then addressed Council. She stated that she was glad to be here on behalf of Rural Development. She stated that the City put in an application for a Community Facilities Grant in the amount of \$50,000 to assist with the purchasing of the emergency radio to allow the City to be able to connect to the new County system. This is part of the whole project which costs \$362,000, and the Rural Development portion is a grant for \$50,000. We are glad to help and partner with the City again to help you obtain some needed equipment for the City. That's what we are here to vote on tonight. The Mayor then said, we appreciate Rural Development's help on all the other projects, too. The City of Walterboro and Colleton County appreciate that very much.

3. <u>Consideration of Purchasing 100 S. Jefferies with HUD Grant Received for Great Swamp Sanctuary Discovery Center and Associated Streetscape.</u>

A motion was made by Council Member Broderick to purchase the property at 100 S. Jefferies Blvd. and to authorize the Mayor (William T. Young, Jr.) to sign the closing documents on the property. Council Member Bobby Bonds seconded the motion that passed with a vote of 6/0 with Mayor William T. Young Jr., and Council Members Jimmy Syfrett, Paul Siegel, Tom Lohr, Bobby Bonds and James Broderick voting in favor. In discussing the motion, Council Member Siegel asked what was the purchase price. The City Manager, Jeffrey V. Lord, responded that the City has a HUD grant for the Great Swamp Sanctuary Discovery Center and the amount available is \$297,000. The purchase price is \$240,000, and there were two appraisals made. Council Member Siegel then asked if only grant funds would be used at this time for the purchase. City Manager Lord noted that this was correct. Council Member Siegel then asked what is the deadline for the closing on this transaction. Mr. Lord responded that we can draw down the money immediately, so it should be coming in.
