WHEREAS, in 2013, an estimated 45,220 people will be diagnosed with pancreatic cancer in the United States and 38,460 will die from the disease; and

WHEREAS, pancreatic cancer is one of the deadliest cancers, is the fourth leading cause of cancer death in the United States, and is the only major cancer with a five-year relative survival rate in the single digits at just six percent; and

WHEREAS, when symptoms of pancreatic cancer present themselves, it is late stage, and 73 percent of pancreatic cancer patients die within the first year of their diagnosis while 94 percent of pancreatic cancer patients die within the first five years; and

WHEREAS, approximately 600 deaths will occur in South Carolina in 2013; and

WHEREAS, the incidence and death rate for pancreatic cancer are increasing and pancreatic cancer is anticipated to move from the fourth to the second leading cause of cancer death in the U.S. by 2020; and

WHEREAS, the U.S. Congress passed the Recalcitrant Cancer Research Act last year, which calls on the National Cancer Institute to develop a scientific frameworks, or strategic plans, for pancreatic cancer and other deadly cancers, which will help provide the strategic direction and guidance needed to make true progress against these diseases; and

WHEREAS, the Pancreatic Cancer Action Network is the first and only national patient advocacy organization that serves the pancreatic cancer community in the City of Walterboro, SC and nationwide by focusing its efforts on public policy, research funding, patient services, and public awareness and education related to developing effective treatments and a cure for pancreatic cancer; and

WHEREAS, the Pancreatic Cancer Action Network and its affiliates in the City of Walterboro support those patients currently battling pancreatic cancer, as well as to those who have lost their lives to the disease, and are committed to nothing less than a cure; and WHEREAS, the good health and well-being of the residents of the City of Walterboro are enhanced as a direct result of increased awareness about pancreatic cancer and research into early detection, causes, and effective treatments.

THEREFORE, BE IT RESOLVED, by the Mayor and City Council of the City of Walterboro, in Council Assembled, that November 2013 shall be designated as:

"Pancreatic Cancer Awareness Month"

in the City of Walterboro, and encourage all citizens to support the Pancreatic Cancer Action Network.

Dear Mayor William T. Young, Jr.:

I am writing on behalf of the Pancreatic Cancer Action Network and the estimated 38,460 Americans who will die of pancreatic cancer in 2013, approximately 600 of whom live in South Carolina. In 2013, pancreatic cancer will afflict more than 45,220 Americans, 73% of whom will die within one year of their diagnosis, and 94% of whom will die within five years of diagnosis.

This cause is extremely important to me because my mother was diagnosed with Stage IV, inoperable pancreatic cancer on 10/25/10. When she asked her oncologist for a prognosis, he told her, "I can't even promise you next week." In 2013, it is absolutely shameful that a healthcare professional of any sort should have that kind of mindset about any disease. Like most of its victims, my mother had no real symptoms; the most "significant" – the one that finally made her see her doctor – was an upset stomach.

Only 9 months and 22 days after diagnosis, my mother – my best friend – entered the gates of heaven. I was by her side through her entire ordeal – all of her chemo treatments, all of the phone calls to the on-call oncologist, midnight trips to the pharmacy, excursions to the ER. I was right by her side as her body shut down, one organ after the next, and ultimately as she took her final breath. No one deserves to endure the suffering that comes with the diagnosis of pancreatic cancer, and yet so few people really know anything about it!

To date, pancreatic cancer is the fourth leading cause of cancer death in the United States, and it is the only major cancer with a five-year relative survival rate in the single digits at just six percent. Furthermore, the incidence and death rate for pancreatic cancer are increasing, and pancreatic cancer is anticipated to move from the fourth to the second leading cause of cancer death in the U.S. by 2020. We need your help to shine a spotlight on this disease and finally make progress in developing treatments and early detection tools. By issuing a proclamation supporting the observance of November 2013 as Pancreatic Cancer Awareness Month in the City of Walterboro, you can help us to raise awareness in our community.

I have attached a draft of the proclamation text for your review. I am happy to provide additional official Pancreatic Cancer Action Network material, including pancreatic cancer facts and statistics and (NCI) funding information, upon request.

We received our quote from SCMIT (Municipal Association Workers Compensation carrier) and even though our experience rating has trended down, it still includes a \$50,000 per occurrence deductible to get the rate down to less than an alternative quote from an independent broker, Gallagher Associates.

We have used Gallagher in the past for other insurance and our staff, that was here then, has a favorable memory of the relationship. Our reference checks on them were very positive.

The Gallagher quote is through the State Accident Fund for \$129,246, before a credit of approximately \$5,600 for our Drug-free Workplace. Net of approximately \$124,000.

The SCMIT quote is for \$108,414. The SCMIT quote for a comparable zero-deductible policy is \$185,641. Our average payout under the "\$50,000 per occurrence deductible" has been \$68,501 over the last five years, and since it is not capped, it could be even higher in the future.

Another major factor is that SCMIT tends to pay claims more readily, with less follow-up, than the State Accident Fund and since we insure 100% of the small claims, this really does drive up our experience rating. They control the determinations but we must reimburse them for the claims.

Further, the SCMIT training programs are rather limited and are general for all municipalities whereas the Gallagher quote includes four days of on-site consultations that their safety coordinator can tailor to the specific needs of the City of Walterboro.

For these reasons, I recommend we make a change, effective on our policy anniversary of January1, 2014.

II. Narrative

The Colleton Center and Coastal Electric Cooperative's community assistance program, the Coastal Electric Trust Incorporated (both 501(c)3 organizations, are co-hosting a South Carolina Barbeque Association (SCBA) Cook-Off on the weekend of Friday, March 21st, and Saturday, March 22nd, at Coastal Electric's Outback facility located on Jefferies Boulevard. Power, water, parking, and the Outback building for the competition judging, make this an ideal location.

The event will be developed under the direction of Wayne Keith, an SCBA-certified barbeque judge, who has taken part in a number of cook-offs as a judge and earlier as a member of a cooking team. He and his family also owned and operated Keith's Barbeque here in Walterboro. Mr. Keith has a lifetime of experience in the barbeque world.

The event will consist of two separate cook-offs. Friday night will be an "Anything Butt" night. Cooking teams will prepare anything from brownies to chicken wings to seafood; it is their choice. The public will purchase tickets for \$1.00 each, as many as they wish, then circulate among the participant booths tasting the fare offered. At the end of the tasting period, prizes will be awarded based on the number of "tasting tickets" collected at each booth. The winners will be announced and prizes awarded on Saturday afternoon.

The main cook-off for the best barbequed Boston Butt will occur on Saturday morning. Based on the number of cook-off participants, twenty to forty judges, SCBA-certified and novice level, will assess the entries. The judges will be under the direction of an event Marshall; in our case the Marshall will be Lake E. High, Jr., the president of the South Carolina Barbeque Association. Everything will be conducted in accordance with SCBA requirements and guidelines. All participants will know ahead of time what those requirements are. The goal is to have twenty cooking teams who will pay \$150 to \$200 (depending on the date of sign-up) for the privilege of participating. Prizes for the top five will be a trophy (modeled after the Red Rocker logo) or a plaque, and cash ranging from \$150 to \$1,000. Participants may come from all over the State. Local participation is also encouraged. Seven SCBA members and three local teams have already expressed an interest in competing.

Just as with the Friday night event, the public will purchase tasting tickets for \$1.00 each in order to sample Saturday's barbeque. Soft drinks, water, and beer will be available each day at booths set up under agreement with the Colleton Center and Coastal Electric. Sales of drinks will be controlled through the ticket process. Bracelets or hand stamps will be issued with proof of age. Without that stamp or bracelet, no alcohol purchase will be allowed. With it, only one glass of beer can be purchased at a time. Permits for the sale of beer will be obtained as required. Most localities have found that beer and soft drink companies are willing to donate their products, so at this point no cost for these items is included in the budget.

The event will also feature live music and a separate area on Saturday for local churches to sell baked goods. This will be a family weekend event.

A budget for the event is included as an attachment to this application. The budget is based on twenty cook-off teams. The Colleton Center and Coastal Electric are requesting \$4,600 from A-Tax to cover Porta-Potty rentals, trash containers and collection, printing and advertising costs. Printing will cover such items as posters, postcards, and banners used to promote the event. Advertising, which has already begun on the SCBA website, will continue through the local print media, additional websites, and with funding from A-Tax through newspapers in such areas as Summerville, Charleston, Orangeburg, Columbia, etc. Barbeque cook-offs are popular events, and it is expected that attendees will be equally divided between locals and cook-off fans from a fifty to sixty mile radius around Walterboro. The SCBA events have a loyal following from all over South Carolina and the southeast region.

III. Benefit to Tourism

This Cook-Off will attract people from around the State with emphasis on the southeastern quadrant. The barbeque world is a fervent and competitive world. There is even a television program devoted to the cook-off experience. Because this is a two day event, visitors, judges, and some participants will stay in local motels and campgrounds. There will be "spin off" shopping trips, breakfast and gasoline purchases. This is an opportunity to bring people to Colleton County for a positive and popular event; give them two days of fun, food, and festivities; and entice them to come back later for more.

IV. Benefit to the Community

The Colleton community benefits from this event in a number of ways. First, as stated in the preceding paragraph, there is an economic gain for local businesses. Secondly, local residents who wish to try their hand at competitive cooking have the opportunity to do so right here at home. Thirdly, the event gives everyone an opportunity to enjoy a family-friendly weekend. This will be a positive, neighborly event featuring good food, fellowship, and spirited competition --- an affirmation of the good life in Colleton County.

V. Tracking

Three years ago a local hospice organization in Beaufort sponsored their first SCBA barbeque. They drew approximately 500 visitors. That number has now grown to 2,000. Other localities similar to Colleton County have had the same crowd experience. For our planning purposes, we are estimating that 400 people will attend the Colleton Cook-Off during the two-day event. Tracking will be done through head count estimates, ticket sale calculation, and food and drink consumption.

VI Duration of Project

The Colleton Barbeque Cook-Off will take place on Friday, March 21st, through Saturday, March 22nd.

VII Permits

Beer/wine permits, any required DHEC permits, and any permissions for banner display or signage will be obtained prior to the event.

VIII Additional Comments

The barbeque cook-off is the kind of event that gains momentum through success. It is hoped that this will become an annual event for Colleton County, increasing each year in scope, competitors, and participating visitors.

The Colleton Center is a 501(c)3 organization whose mission is to provide for the renovation and restoration of the historic Hampton Street Elementary School building and for the development of a premiere arts and civic center, serving the interests and talents of the diverse lowcounty residents and visitors.

Operation Round Up® is a Coastal Electric Cooperative community service assistance program governed and executed by Coastal Electric Trust, Inc., a 501(c)3 corporation. Contributions to Coastal Electric Trust are used to assist local individuals or families with special needs or requests. These needs include but are not limited to food, shelter, clothing, healthcare, education and accessibility needs. Funds, once approved, are used to pay bills or for services directly and are never given to the individual or family making the request. Coastal Electric Trust has been an active service provider in the community for over 20 years.

II. NARRATIVE

The South Carolina Humanities Council has selected Colleton County as the location for its 2014 annual festival on the weekend of March 7th through the 9th. A committee of local organizations – Colleton Museum and Farmers Market, Colleton Center, Colleton County Memorial Library, Colleton County Historical & Preservation Society, South Carolina Artisans Center, and Colleton County Arts Council – have joined together to develop and host a wide ranging series of events, demonstrations, classes, tours, and exhibits to welcome festival participants and to showcase the many attractions offered by Colleton County.

The Humanities Council estimates total attendance at events in the four to six hundred range. Past conventions such as Sumter recorded 1,100 participants and Bennetsville/Chester 400 participants. In order to defray the cost of the events, the Humanities Council provides the host with a grant of \$3,000. The Colleton Committee is requesting an additional \$7,000 from City of Walterboro Accommodations Tax. Because expenditures will be handled through a special grant fund set up for the Museum within the County government budget, the Museum is listed here as the applicant agency, but it is the Committee as a whole that is seeking the funding assistance.

A complete budget is included as an attachment to this application. Also included is a list of planned events. Detailed scheduling is still being determined. All events are open to both convention participants and interested residents/visitors. Most events will be free of charge, however, some of the classes will have enrollment fees and limits on the numbers of participants. These enrollment fees will go directly to the teacher/presenter in lieu of honorarium or Committee payment, and so are not included as revenue in the attached budget. Both the opening and closing events (Shag at the Museum and Champagne Breakfast) and the guided driving tour will have admission charges. Projected receipts are included in the revenue side of the budget.

A-Tax funds will be used to cover Honorariums, Printing, Advertising, and some of the Participant Event Packet costs. The Printing costs include banners, maps, event programs, brochures, and posters which will highlight both the entire convention and individual events within the program. Advertising will cover both local print media and such publications as Skirt, Charleston Mercury, Island Publications, Summerville Communications, and the Island Packet. This event should draw interest from surrounding counties as well as from Humanities Council members from across the state. It is the goal of the Committee to confine requests for private donations from local businesses and residents to in-kind services only in deference to the many other events supported throughout the year by this generous pool of donors.

All of the organizations making up this event committee have experience with programming, budgets, and volunteer management. The various boards and memberships will be providing labor and expertise to make the event a success. The funding will pass through the County Budget and will be subject to all County auditing and reporting requirements.

III BENEFIT TO TOURISM

This event will attract people from around the state and the local area. Many of the Humanities Council members will be arriving in Colleton County on Friday and staying in local hotels/motels/B&B's until the closing event on Sunday. These visitors will participate in the scheduled events, but will also frequent local restaurants for meals and shop the downtown antique, clothing, and gift shops. Day-trippers from neighboring communities will do the same. Both groups will leave with a greater appreciation of what is available here in Colleton County with the result that return traffic can be expected. This is an excellent opportunity to further polish the image of Colleton County as a thriving, interesting community with an award-winning museum, vibrant shopping opportunities for everything from farmers market produce to arts and antiques, beautiful natural landscapes, and tournament-ready recreational facilities.

IV BENEFIT TO THE COMMUNITY

The South Carolina Humanities Council's selection of Colleton County as the site of their 2014 convention is a win/win situation for this community. As stated in the preceding paragraph, this is an excellent opportunity for Colleton County to showcase itself to people from across the state. It is a chance for neighbors near and far to get to know and appreciate what we residents can enjoy every day. In addition, our community benefits from the revenues the event will bring into the local economy during the scheduled programming, and will benefit in the future as people return here to shop, explore, and vacation. Since residents are also invited and encouraged to participate in the convention events (most of which are free of charge), there is the opportunity to experiment with the demonstrated arts and crafts, to learn about our own history, to discover local craftsmen, and to have a fun, family day right here in our own community.

V TRACKING

Numbers of projected out-of-County participants are based on South Carolina Humanities Commission past experience. It is estimated that approximately one hundred people will come to Colleton for the weekend convention staying in local hotels, motels, and B&B's. An additional two hundred people will travel here for a day-long visit on Friday or Saturday. Visitors unconnected with the Commission, but attracted by the scheduled events are expected to number at about one hundred. Local participation will add at least that many again to the overall convention numbers. Tracking will occur through convention registration, event ticket sales (where applicable), sign-up sheets, and estimated head count at separate events.

VI DURATION OF PROJECT

The convention will take place on the weekend of Friday, March 7th through Sunday, the 9th. Some visitors may arrive on Thursday the 6th.

ARTICLE III. LIVESTOCK

Sec. 4-63. Definition; at large; seizure authorized. Sec. 4-64. Nuisances---Failure to abate. Sec. 4-65. Same---Cows. chickens. etc.; stables. Sec. 4-66. Slaughterhouses prohibited. Secs. 4-67---4-85. Reserved.

Sec. 4-63. Definition; at large; seizure authorized.



Livestock, means animals of a domesticated, agricultural nature, including, but not limited to, equine animals, bovine animals, fowl, sheep, goats, llamas, and swine.

No livestock shall be kept within the corporate limits without specific City Council approval. No approval shall be granted or continued if such keeping shall constitute a misdemeanor.

- (c) It shall be unlawful for any animal, herein defined as a horse, mule, swine, sheep, goat, goose, turkey, chicken, peacock, cattle or other livestock or domestic fowl of any description, to run at large within the City corporate limits.
- (d) It shall be the duty of the Animal Control Officer to seize all such animals found running at large and to impound them.

(Code 1994, §§ 3-1, 3-2; Code 2003, § 3.301)

Sec. 4-64. Nuisances—Failure to abate.

- (a) Any livestock which shall by sound, odor or sight materially interfere with or affect the health, comfort, peace or quiet of the people is hereby declared to be a nuisance.
- (b) Any person harboring, keeping in possession or having in custody or control any livestock which constitutes a nuisance, who shall fail or refuse to take such action or do such things as will abate such nuisance when requested in writing to do so by the Animal Control Officer, upon conviction, shall be guilty of a misdemeanor.

(Code 2003, § 3.302)

Sec. 4-65. Same-Cows, chickens, etc.; stables.

- (a) It shall be unlawful for any person to keep cows or chickens, or any other animal in such a manner as to create a nuisance.
- (b) All stables, houses and barns shall:
 - (1) Be kept in a clean and sanitary condition and manure not allowed to accumulate; and
 - (2) Be subject to regulations prescribed by appropriate City or County authority.
