### NOTICE OF PUBLIC HEARING

NOTICE IS HEREBY GIVEN that on Tuesday, April 12, 2011 at 6:00 p.m. at Walterboro City Hall, the City of Walterboro will hold a public hearing concerning an application to be submitted to South Carolina Department of Commerce, Grants Administration on or about April 18, 2011, for a Community Development Block Grant. The City of Walterboro is requesting approximately \$285,000 to carry out the following activities:

The City of Walterboro proposes to use CDBG funds to upgrade the pump station located at the corner of Jackson Street and Sheldon Street by upgrading to a submersible type with new pumps, piping, controls and a permanent bypass. This pump station has become outdated and problematic, resulting in sewer overflows. This project will benefit approximately 321 residents of which 82% are low-to-moderate income.

This public hearing and the matters to be discussed are subject to the provisions of the City of Walterboro's Citizen Participation Plan, developed in anticipation of participation in the State of South Carolina's Community Development Block Grant (CDBG) Program, providing for the participation of the citizens of the City of Walterboro in the planning and implementation of community and economic development projects which will involve CDBG funds. The Citizen Participation Plan and the application are available for review at Walterboro City Hall, during regular business hours. ### **NEW BUSINESS:**

### 1. Resolution No. 2011-R-06, Fair Housing Month, April 2011, and Nondiscrimination Policy

The Mayor entertained a motion to adopt Resolution No. 2011-R-06 as submitted. Council Member Lucas Moved to adopt Resolution No. 2011-R-06 as submitted. Council Member Peters seconded the motion. The motion passed with all members voting in favor, except Council Member Buckner was absent and did not vote. A copy of said resolution is attached and made a part of these minutes.

## 2. Approval of Subrecipient Agreement Between Beaufort County/Lowcountry Regional Home Consortium and the City of Walterboro and Acceptance of Home Consortium Award in the amount of \$168,750

Mayor Young explained that the city was able to use some of it's Public Safety Initiative Money and combine it with the Home Consortium Money to do even more rehab work. City Manager Lord stated that the public safety initiative used the CDBG Funding which would be used for things like demolition and building rehab, but the building rehab is restrictive to only exterior work. The Home Consortium has offered to provide \$150,000 and the local match (\$18,750) for those same structures to get interior renovations. So, while we are there, we can help them inside the house, as well as outside the house.

A motion was made by Council Member Smalls to approve the Subrecipient Agreement between Beaufort County/Lowcountry Regional Home Consortium and the City of Walterboro as submitted and to accept the Home Consortium Award in the amount of \$168,750. Council Member Lucas seconded the motion. In discussing the motion, Council Member Smalls asked if the houses to be rehabed had been identified and named already? City Manager Lord responded that the city had identified structures that "can be". We have been in contact with the homeowners trying to identify those who might be interested. There has not been a final list made, because we have to go through a qualifications stage, and CDBG will handle that part. Part of the \$18,750 is for a certified building appraiser, who will look at the structures to see what qualifies and how much it will cost. So, we are working on the list, but there has not been a hard list made yet.

Mayor Young added, "we are the only county (Colleton County) in the past in the Lowcountry Council of Governments that has not been able to make use of Home Consortium money". Beaufort, Jasper and Hampton have all been able to make use of those monies. We were able to find a way by partnering the money from the Public Safety Initiate to make use of the funds, and now we are getting an extra (almost) \$170,000. I want to thank staff for making that happen.

On a question raised by Council Member Peters, City Manager Lord responded that the Home Consortium is providing the 'match and the grant'.

The motion then passed with all members voting in favor, except Council Member Buckner was absent and did not vote.

### 3. <u>Funding Recommendations form the Accommodations Tax Advisory</u> Committee

Mr. Lord announced that the Accommodations Tax Advisory Board met on March 3, 2011 and there was only one request before them, and it was from the City of Walterboro for \$12,000 to help promote events this spring. There are several events going on - the Criterium, the Rice Festival, the Rudy Manke Event, etc. While some of those events have gotten funding on their own, the City is

experiencing a lot of requests for information. So, this is to help us respond to those requests. The funding recommendation submitted was as follows:

The A-Tax Advisory Board recommended that City Council approve this request.

The Mayor then entertained a motion to approve the funding recommendation from the Accommodations Tax Advisory Committee as submitted. Council Member Parker made a motion for approval, and Council Member Smalls seconded the motion. In discussing the motion, Council Member Peters asked how much money would be left in this fund? City Manager Lord responded, we are showing after this award, if it is approved, another \$51,218 projected would be available as a carryover for next year.

Council Members Peters asked if the Committee would meet again in July? Mr. Lord responded that the Committee would meet In June for next year. This was the last funding round for this year.

Mr. Peters then said, so we still have that much money left to spend in 2011? Mr. Lord affirmed, yes, but it rolled over to the next year if it is not used. Mr. Peters then asked the City Manager, do you know why nobody requested any money? Mr. Lord responded, no, sometimes we get a bunch of people to ask and sometimes we don't.

The motion to approve the funding recommendation from the Accommodations Tax Advisory Committee as submitted then passed with all members present voting in favor. Council Member Buckner was absent and did not vote.

### 4. Request to Use the City Parking Lot May 21, 2011 for Walterboro Police Week Event and Hang Informational Banner May 15-21, 2011.

Ms. Donna Laird, Tourism Director, announced that the Walterboro "Police Week" event will be held on Saturday, May 21, 2011 in the City Parking Lot from 11: 00 A.M. to 1:00 P.M. This is a free event, assisted by Ms. Jackie Dasen, and is an opportunity for the officers to relate to the community. There will be K-9 demos, safe kids demos, finger printing, games, raffle prizes and more. We will recognize our Department's dedication to the community's public safety as we welcome and include various area officers to join us.

Mr. Lord responded that we received this cost from the County Elections & Voter Registration Board. Mayor Young asked if that was the actual cost to print a ballot? City Manager Lord explained that this is the price they are charging us to do it. Mayor Young then asked, do they have to do it? He asked the City Manager to find an answer to the question.

The Mayor entertained a motion to approve the two budgets for the 2011 Municipal General Election as presented. Council Member Lucas so moved, and Council Member Parker seconded the motion. In discussing the motion, Council Member Buckner asked if the number of poll workers (6) and poll managers (2) were sufficient to have a smooth election? ### ORDINANCE # 2011-04

AN ORDINANCE ALLOWING THE CITY OF WALTERBORO TO JOIN THE COUNTY OF COLLETON IN ABOLISHING WALTERBORO-COLLETON CITY-COUNTY RECREATION COMMISSION AKA THE "WALTERBORO-COLLETON COUNTY RECREATION COMMISSION" AKA THE "WALTERBORO-COLLETON COUNTY RECREATION AND PARKS COMMISSION"; AND ABOLISHING SAID COMMISSION

WHEREAS, The Walterboro-Colleton City-County Recreation Commission was established by the South Carolina legislature by Act 628 of 1973 as amended by Act 853 of 1973, which created the Walterboro-Colleton City-County Recreation District; and

WHEREAS, The Walterboro-Colleton City-County Recreation Commission was also known as and one and the same commission as the "Walterboro-Colleton County Recreation Commission" and was also known as and one and the same commission as the "Walterboro-Colleton County Recreation and Parks Commission"; and

WHEREAS, the County of Colleton has previously adopted Ordinance 09-O-15 to abolish The Walterboro-Colleton City-County Recreation Commission aka the "Walterboro-Colleton County Recreation Commission" aka the "Walterboro-Colleton County Recreation and Parks Commission" which was established by the above referenced local legislation; and

WHEREAS, the City of Walterboro now wishes to join with the County of Colleton in the exercise of the authority granted to municipal corporations and counties generally by the South Carolina Code of Laws, 1976 as amended, to abolish The Walterboro-Colleton City-County Recreation Commission aka the "Walterboro-Colleton County Recreation Commission" aka the "Walterboro-Colleton County Recreation and Parks Commission" which was established by the above referenced local legislation; and

WHEREAS, the intent of this ordinance is to fully exercise the authority of the County of Colleton and the City of Walterboro under the Constitution and laws of the State of South Carolina and to supersede any local and/or special legislation related to The Walterboro-Colleton City-County Recreation Commission, enacted prior to the adoption of the current versions of Article VIII, § 7 and Article VIII, § 8 of the South Carolina Constitution,

NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF WALTERBORO, IN COUNCIL ASSEMBLED, AS FOLLOWS:

### SECTION I

The City of Walterboro hereby joins with the County of Colleton in abolishing The Walterboro-Colleton City-County Recreation Commission aka the "Walterboro-Colleton County Recreation Commission" aka the "Walterboro-Colleton County Recreation and Parks Commission" which was established by the above referenced local legislation, and abolishes and declares abolished said Commission.

### SECTION II

AN ORDINANCE AUTHORIZING THE CONVEYANCE OF A TWENTY-ONE (21) ACRES, MORE OR LESS, TRACT OF LAND, TO THE COUNTY OF COLLETON, A BODY CORPORATE AND POLITIC

WHEREAS, the City of Walterboro entered into a Memorandum of Understanding, with the County of Colleton, approved by Colleton County Council on August 4, 2009 and approved by Walterboro City Council on August 25, 2009; and

WHEREAS, the terms of that Memorandum of Understanding
provided, inter alia, :

"5. The City agrees to sell for one dollar (\$1.00) the interest in the following property which it currently owns, which are in the unincorporated areas of the County and which are currently used by the Walterboro Colleton County Recreation Commission:


