Minutes

A Regular Meeting of Walterboro City Council was held at City Hall on Tuesday, August 1, 2023, at 6:15 P.M., with Mayor Bill Young presiding.

<u>Present:</u> Joined in the meeting were: Mayor Bill Young, Councilmembers: Ladson Fishburne, James Broderick, Paul Siegel, Judy Bridge, and Carl Brown. City Manager Jeff Molinari, City Clerk Adrienne Nettles, City Attorney Brown McLeod, Parks Director Jonathan Burroughs, Utilities Director Wayne Crosby, and Walterboro Police Officer Ross Hant were in attendance. Councilmember Greg Pryor was not in attendance.

Call to Order:

With the above-mentioned Councilmembers present, Mayor Young called the meeting to order, and invited everyone to join in as he gave the invocation. Councilmember Brown led the Pledge of Allegiance to our flag.

City Manager Jeff Molinari stated we take the anticipated local option sales tax collections for the year and divide it by the total appraised value of property in the city and that gives us a sales tax credit factor of .002218. That number will be reflected in the tax bills that will go out in the Fall.



(WSP) is pleased to submit this work order to provide additional engineering services for surveying services and preliminary project coordination for the Ireland Creek Park and Greenway project. Included in this work order is our understanding of the scope of services, our fee, schedule, and authorization procedures.

PROJECT INFORMATION

Summary Background

WSP has previously provided the City of Walterboro (City) with a Master Plan for Ireland Creek Park and Greenway. WSP understands that the City would like WSP to provide an engineering services contract to prepare Design Documents (construction drawings) and specifications that the City can submit to contractors for bid and construction. As a first step in the process, a topographic and limited boundary survey will be needed for the project area.

Commencing upon written authorization to proceed, WSP will provide professional services to produce the following deliverables.

Boundary and Topographic Survey

WSP will engage a surveyor, expected to be Atlas Surveying, Inc., to provide limited boundary survey (property corners encountered will be marked where not present, iron pins will be placed and surveyed at the corners), one-foot contour topographical survey, underground utilities, tree locations and existing conditions survey. Existing conditions will include natural and man-made features located within the survey corridor. This may include, but not be limited to, buildings, fences, parking areas, pavement, impermeable features, and utilities and appurtenances that are apparent by visual inspection. Trees referenced in the City's grand tree ordinance will be located. Flood elevations and full pool water elevations will be noted. Survey will be limited to the shaded portions of the parcels shown in the attached map (Appendix A). The survey will be certified in accordance with South Carolina requirements. Utilities will be delineated inside the public right-of-way based on South Carolina 811 services. Deliverables will include a CAD file and a certified Improvements/Topographic Survey.

Detailed Survey Scope of Services

The survey will include the identified property survey area (Appendix A) including roads and right-of-way limits within the project area unless noted otherwise. The survey will meet the Standards of Practice Manual for Land Surveying in South Carolina as described in relevant regulations with accuracy agreed upon with owner, engineer, and surveyor.

The database will be prepared with match lines, sheet numbers, and a key map. These drawings will be used as the basis to prepare the construction documents for bidding.

Horizontal and vertical control for the project in accordance with the state plane coordinate system will be established by the surveyor in agreement with WSP. A control baseline with stationing will be laid out and tied to the control points developed during the database preparation.

TASK 1A: BOUNDARY SURVEY AND TOPOGRAPHIC SURVEY

Property & Deed Research:

Surveyor will conduct research at the Colleton County Courthouse to establish the tax identification number, property owner's name, and current deed book and page number for each property within the survey limits. Additional research will be performed to uncover major easements and recorded rights-of-way. Existing Deeds, Plats, and Easements search is limited to a Grantor/Grantee Search from the date of the current deed, forward to the executed date of the "Consultant/Sub-consultant Agreement".

Horizontal & Vertical Control:

Surveyor will perform research to obtain monument descriptions; coordinate values, and field recover existing State Geodetic and National Geodetic Survey monuments that are closest to the project limits. Using this information, a horizontal and vertical control network will be established along the project limits.

The horizontal control traverse will be referenced and adjusted to the NAD 83/2011 datum. Project coordinates will be localized around one control point set near one end of the project. Horizontal control traverses will conform to standard set for third order class I surveys (1:10,000) or as agreed upon with WSP. Horizontal control points will be monumented by placing 36-foot rebar with aluminum caps or as outlined in local survey standards and regulations.

Vertical control bench loops will be established along the project corridor and benchmarks will be established at 500-foot intervals. Temporary benchmarks will be placed outside of the construction limits when possible. Benchmarks will have third-order closure accuracy and will be based on NAVD 88, or other datum as agreed upon with WSP.

Boundary Ties and Property Mapping:

Surveyor will perform field surveys to delineate existing property lines, rights-of-way, and easements within the project limits. Existing property lines will be mapped based on existing property monumentation and recorded deeds and plats. The property surveys do not constitute a boundary survey of each parcel, but instead are intended to provide sufficient information for the preparation of right-of-way and easement acquisition plats.

Digital Terrain Model:

Horizontal and vertical data points will be collected throughout the project corridor to create a triangular irregular network (TIN) for the purpose of defining the existing topography and grades using a one-foot contour interval (I foot minor/5 foot major). Index and intermediate contours will be shown in the plan view. Index contours will contain elevations labels. Vertical elevation will be within a tolerance of 0.01 foot and horizontal location will be within a tolerance of 0.10 foot. Spot elevations will be provided for above ground fixed features such as building thresholds, manhole covers, curbs, meter boxes, poles, and signs.

Vertical control bench loops will be established within the project area and benchmarks will be established at 500-foot intervals along road corridors. Temporary benchmarks placed outside of the

construction limits will be used when possible. Benchmarks will have third-order closure accuracy of 0.05 feet $\sqrt{\text{miles}}$ (English) or 12 millimeter $\sqrt{\text{kilometer}}$ (Metric).

Plan View Mapping:

Field surveys will be performed to locate and map information within the project limits. Location will include the following items:

- Road pavement limits.
- Driveway location and type (concrete, gravel, asphalt).
- Top and bottom of curbs (at 50-foot intervals)
- Building/structure corners and type.
- Building Finished Floor Elevation (FFE) and doorway thresholds.
- Limits of wooded areas and limits of vegetation.
- A tree survey will be performed throughout project area (yellow shaded areas on the map in Appendix A) for trees regulated by City tree ordinance or a diameter at breast height (DBH) of 10-inch or larger. Surveyor will note species of tree and diameter of tree on provided mapping. Tree survey will extend over the survey area (yellow-shaded area on attached map). Tree survey may be accomplished utilizing survey grade GPS.
- Signs to include road signs, business signs, and billboards.
- Fence location and type.
- Sanitary Sewer System (location, size, type, and elevation of inverts and tops).
- Drainage features/Storm Sewer System (location size, type, and elevations or invert and rim elevations and pipe diameters/materials, if possible).
- Retaining walls (bottom and top of wall).
- At-grade and above-grade utility locations and identifiers (valve boxes, manholes, light poles, post-indicator valves, fire hydrants).
- Water Lines location of above-ground appurtenances such as valves, meters, and hydrants.
 Does not include underground location (See Task 1B).
- Gas Lines location of above-ground appurtenances, such as valves, meters, and vents. Does
 not include underground location (See Task 1B).).
- Telephone location of above-ground appurtenances such as poles, pedestals, and manhole access covers. Does not include underground location (See SUE Mapping).
- Power location of above-ground appurtenances, such as poles, pedestals, and manhole access covers. Does not include underground location (See Task 1B).).
- Cable TV/Fiber Optic/etc. location of above-ground appurtenances, such as poles and pedestals. Does not include underground location (See Task 1B).).

Hydraulic Survey:

A topographical survey will be performed for the hydraulic features within the project corridors as highlighted in yellow in the map in Appendix A. The project corridors will consist of the designated stream segments, adjacent floodplains and wetlands, and noted restoration/enhancement areas. The existing site survey will describe the existing conditions and allow for characterization of the site, modeling, design, quantity estimates, and other information. The Topographical Survey scope of work will include the following.

Surveyor will set a minimum of two permanent benchmarks with spot elevation data at the top, middle, and end of the stream segment. Each permanent pin will be marked with a PVC witness post, a minimum of three feet in height, and have the elevation permanently recorded on the side of the post. Each permanent pin will be located no greater than 50 feet from and no closer than 10 feet from the top of bank and be within a clear/unobstructed sight distance of no greater than 100 linear feet from one another. Permanent benchmarks may be set with survey grade GPS, where applicable.

- Surveyor will collect sufficient topographic information to represent the existing stream channel/feature and the proposed stream restoration alignment.
- Cross-sections of the existing stream channel/feature will be collected at a maximum distance of 100 linear feet and will extend to no greater than 15 linear feet beyond top of bank (left and right).
- Surveyor will collect topographic cross-sections and underwater break points as necessary to provide accurate location of streams and waterways to create a digital terrain model (DTM) of hydrographic features, if required.
- Where no transition is present between the floodplain and the valley slope within the stream enhancement project corridor, surveyor will extend floodplain survey a minimum of 300 feet beyond top of bank (left and right).
- Surveyor will make note of significant features residing within the stream enhancement corridor to include significant sandbars, depressions, rock outcroppings/grade control, pipes/culverts, structures, and other significant features as may be thought to be pertinent to the stream restoration design.
- Surveyor will include an additional 200 feet upstream and downstream of the proposed project limits in this scope to provide sufficient tie-in information.
- The plan and profile views of the stream corridor will be shown on the drawing with coordinates at the beginning point, the end point, and all points of intersection. Stream centerline will be stationed.
- The edge of water, toe of slopes, top of banks, and terraces, will be shown throughout the project limits. Federal Emergency Management Agency flood limits will also be shown.
- State and local stream buffers will be identified.

Surveyor will develop a three-dimensional DTM for the Ireland Creek Stream corridor. The surveyor will provide one digital copy as an AutoCAD Civil 3D (Version 2016 or later) DWG file.

Road/Bridge Crossings:

Information associated with the three road crossings to be collected/surveyed at West Washington Street, Forest Hill Road, and N. Jeffries Blvd will include:

- Stream channel cross-sections under each bridge and on each side of each bridge crossing.
- Top road elevation, at the structure and up to 100 feet either side (need the road profile at the crossing).
- Bridge low-chord elevation.
- Bridge abutments (elevation at base of abutment).
- Bridge span length.
- Bridge piers (size of pier and elevation at base).
- Photos of structures associated with crossings.

TASK 1B - Underground Utilities (SUE Level B - Non-invasive method)

Surveyor will contact 811 and the City of Walterboro to have existing utilities marked within the survey area. Surveyor will locate utility marking upon completion of the service by others and combine information within the overall survey. Services provided by the private utility marking company will be provided at a Quality Level B (non-invasive) for the overall survey area.

SUE Level B information obtained through the application of appropriate geophysical methods to determine the existence and approximate horizontal location of subsurface utilities will be provided.

Mapping Requirements:

The following items will be submitted at the completion of the survey:

Finished survey will be provided at scale and size as directed by the client.

- Finished products will include a signed and sealed map by a South Carolina-registered Land Surveyor.
- Digital file in CAD format in State Plane Coordinate System with vertical datum NAVD88. with TIN surface and survey point file.

TASK 2 - Initial Project Coordination

WSP will provide preliminary project coordination and consulting services including meetings with City staff, stakeholders including South Carolina Department of Transportation (SCDOT), presentations to City Council and other support related to the Ireland Creek stream restoration and greenway.
