AN ORDINANCE PURSUANT TO TITLE 5, CHAPTER 3, SECTION 5-3-150, SUBSECTION 3, OF THE CODE OF LAWS OF SOUTH CAROLINA, 1976, AS AMENDED, TO ANNEX AN AREA KNOW AS TMS # 180-00-00-107 INTO THE CITY OF WALTERBORO, A SOUTH CAROLINA MUNICIPAL CORPORATION

WHEREAS, a proper petition has been filed with the City of Walterboro Council by 100% of the freeholders owning 100% of the assessed value of the contiguous property hereinafter described petitioning for annexation of the property to the City of Walterboro under the provisions of SC Code Section 5-3-150(3); and

WHEREAS, it appears to Council that annexation would be in the best interest of the property owners and the City of Walterboro; and

ALSO LESS AND EXCEPT that certain 0.118 acres, more or less, as was conveyed to the South Carolina Department of Transportation by Deed recorded in Book 1466, at Page 322.

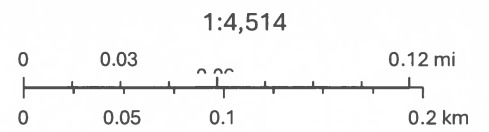

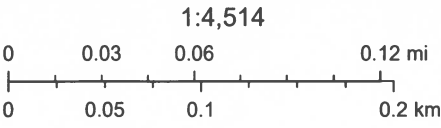

Minutes

A Regular Meeting of Walterboro City Council was held at City Hall on Tuesday, May 6, 2025, at 6:15 P.M., with Mayor Bill Young presiding.

Present: Joined in the meeting were: Mayor Bill Young, Councilmembers: Ladson Fishburne, James Broderick, Paul Siegel, Judy Bridge, and Carl Brown. City Manager Jeff Molinari, Assistant City Manager Ryan McLeod, City Clerk Adrienne Nettles, City Attorney Brown McLeod, Tourism Director Patricia Utsey, Finance Director Amy Risher, Utilities Director Wayne Crosby, Parks Director Jonathan Burroughs, Police Chief Wade Marvin, Colleton County Engineer Carla Harvey, Dana Cheney and Cindy Warren. Councilmember Greg Pryor was not in attendance.

Call to Order:

With the above-mentioned Councilmembers present, Mayor Young called the meeting to order and invited everyone to join in as he gave the invocation. Councilmember Siegel led the Pledge of Allegiance to our flag.

Public Input on Agenda Items:

There was no public input on agenda items.

Presentations:

1. Cindy Warren – Neighborhood Concerns.

1. Ms. Cindy Warren addressed City Council with her concerns about the ongoing crime that is taking place. She also asked what has been done since the 12-Point Plan was put into place. Ms. Warren stated that we need find a way to cut down on all the shooting and crime that is going on in Walterboro.

2. Dana Cheney addressed City Council about the community garden that is at the Artisan Center. He stated that they have tons of vegetables already growing and invited everyone to the grand opening on May 16, 2025.

Public Hearing:

City Manager Jeff Molinari stated Mr. Mayor and members of City Council you have in your agenda packet an ordinance and a map for the property on Moore Street, they are requesting to be rezoned from Industrial District to High Density Residential. It is my understanding that the owner wants to build a single-family residence on that parcel. We recommend approval of second and final reading of the requested zoning change as recommended by the Planning Commission.

1. **Ordinance # 2025-06**, AN ORDINANCE ADOPTING THE CITY GENERAL FUND BUDGET FOR FISCAL YEAR 2025-2026 AND MATTERS RELATING THERETO (Introduction and First Reading).

Councilmember Bridge stated I would like to begin by thanking our City Manager Jeff Molinari and our Finance Director Amy Risher and department heads for the time they put into reviewing their budgets. The FY 2025-2026 budget presented some challenges – lingering inflation, employee retention and recruitment, defunding of the state retirement credit by the General Assembly and increases in employee health insurance premiums. To simplify and streamline the budget, some line items were consolidated and combined into larger line items such as tires to vehicle expense.

In August of 2023, Wildan Financial Services presented their findings from the capital funding analysis that they conducted of the city's water and wastewater operations. Staff took those recommendations and adjusted them to best meet the financial needs of the Enterprise Fund. Adjusting the rate structure in the Enterprise Fund will accomplish the following:

- Full Cost Recovery of Utility Expenditures – generate enough revenue in each system to meet the operational needs of each system (cost-based rate structure).

Budget Summary

- \$15,792,022 total City budget.
- \$9,625,156 General Fund budget.
- \$6,166,866 Enterprise Fund budget.
- No ad valorem property tax increase.
- No business license rate increase.
- Proposed 5% increase in water and wastewater rates.
- The 1% credit for employers' retirement system contributions is no longer funded by the General Assembly.
- Property and casualty insurance (SCMIRF) rates increased by .61%, workers' comp insurance (SCMIT) decreased by 15.2%.

- No change in PEBA health insurance rates (employer).
- PEBA health insurance (employee) increased by \$36.76 per subscriber per month.
- Merit increases for city employees.

City Manager Jeff Molinari stated Mr. Mayor and members of Council you have a resolution that is for the CDBG grant application that we are partnering with the County. Colleton County is the lead on the application on this and we would be the subrecipient if funded. This is a critical project for our water distribution system. This involves the replacement of an 85-year-old well. This well is located at the intersection of Thunderbolt Drive and Recreation Lane. This involves the upgrade of what is referred to as the Stephens Well. This well is located on Industrial Road and would increase the capacity from 660 gallons per minute to 1300 gallons per minute. To give you an idea of the importance of this project, I am going to list several facilities that are served by these two wells: Colleton County High School, Colleton Middle School, Colleton Prep, Northside Elementary, Thunderbolt, Veterans Victory House, Magnolias of Walterboro, Colleton Recreation Center and Colleton County Venture Park. We have several very important facilities that are served by these wells. The matching portion of \$241,281.00 will come from the City's Capacity Fee Fund. We ask for Council's favorable consideration of this resolution.

This is a request to clear the fallen trees in Ireland Creek, from West Washington Street to South Jefferies Blvd. This also includes the removal of two (2) dilapidated bridges in the sanctuary. The Parks Department received one (1) bid and two (2) no bids. Staff recommends awarding the contract to H2O Mitigation out of St. Matthews, SC. This is the same company that completed the tree work for the boardwalk project. The cost is \$90,000 and will be paid from the Capital Project Sales Tax. If approved, H2O Mitigation Services can begin work in the late summer, early fall. We ask for Council's favorable consideration of this request.

Minutes

A Regular Meeting of Walterboro City Council was held at City Hall on Tuesday, June 3, 2025, at 6:15 P.M., with Mayor Bill Young presiding.

Present: Joined in the meeting were: Mayor Bill Young, Councilmembers: Carl Brown, Judy Bridge, Paul Siegel, James Broderick, Greg Pryor, and Ladson Fishburne. City Manager Jeff Molinari, Assistant City Manager Ryan McLeod, City Clerk Adrienne Nettles, City Attorney Brown McLeod, Finance Director Amy Risher, members from the Colleton County School Board, and members from the Libertas Academy.

Call to Order:

With the above-mentioned Councilmembers present, Mayor Young called the meeting to order and invited everyone to join in as he gave the invocation. Councilmember Bridge led the Pledge of Allegiance to our Flag.

Public Input on Agenda Items:

Glenn Nixon, Colleton County School Board Trustee stated I am here this evening to express my concerns about the new charter school. This new school will affect Black Street Early Childhood Center, the church that it backs up to, and the homes in the surrounding area. I am concerned about the impact it will have on the water and sewer capacity as well. The proposed charter school will also take a good bit of funding away from the public school. I ask that the City think long and hard before annexing this property into the city.

Sharon Witkin, Colleton County School Board Trustee stated I am concerned about the impact the charter school will have on the school district, such as enrollment, deductions in resources, and laws that apply to public schools do not apply to charter schools. The addition of this charter school will make the job of the Colleton County School District more difficult. I also ask that the city closely review the water and sewer needs as well.

Destiny Grant, Director of Libertas Academy Colleton Charter School stated Libertas is a public school and we are opening for the 2025-2026 school year. 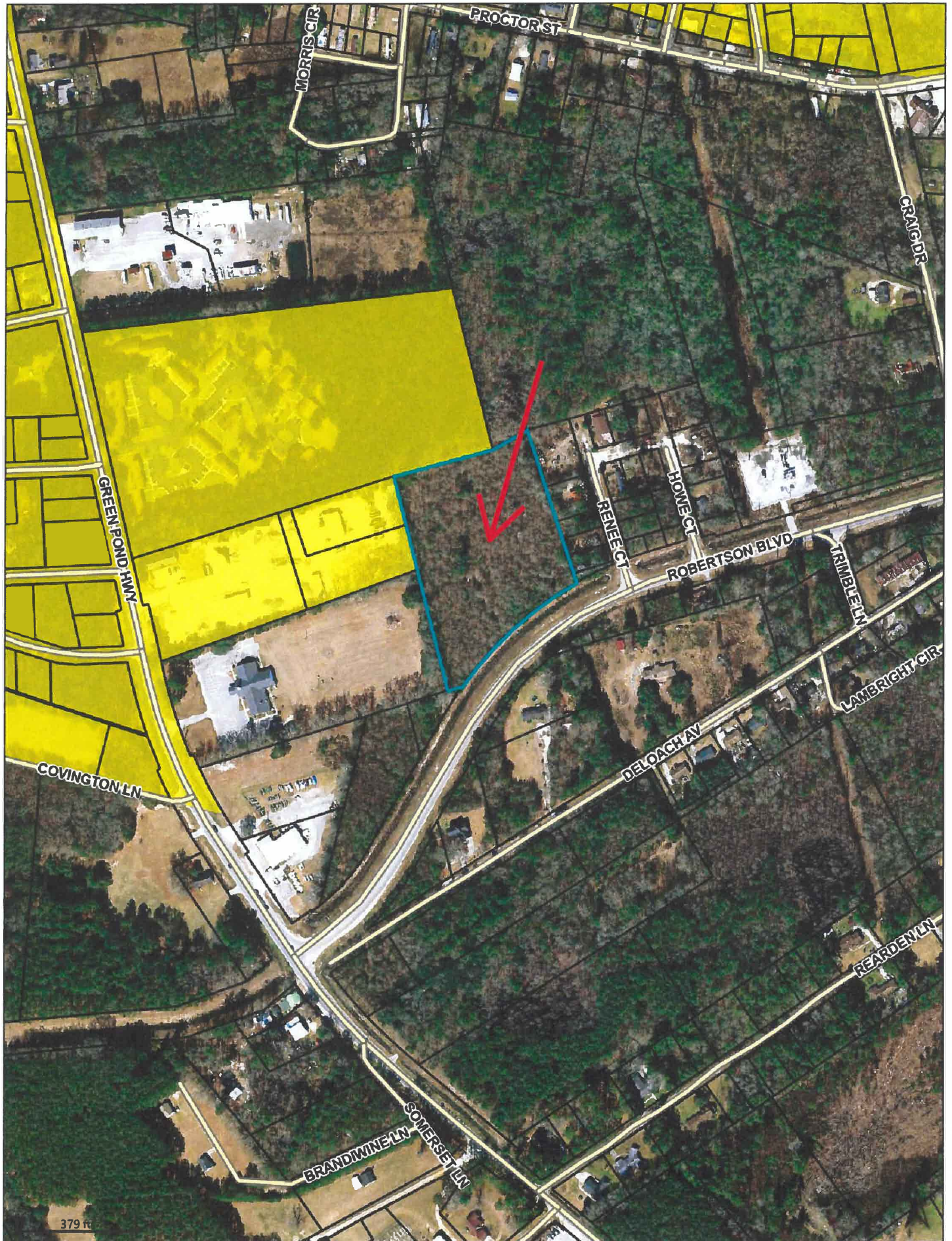

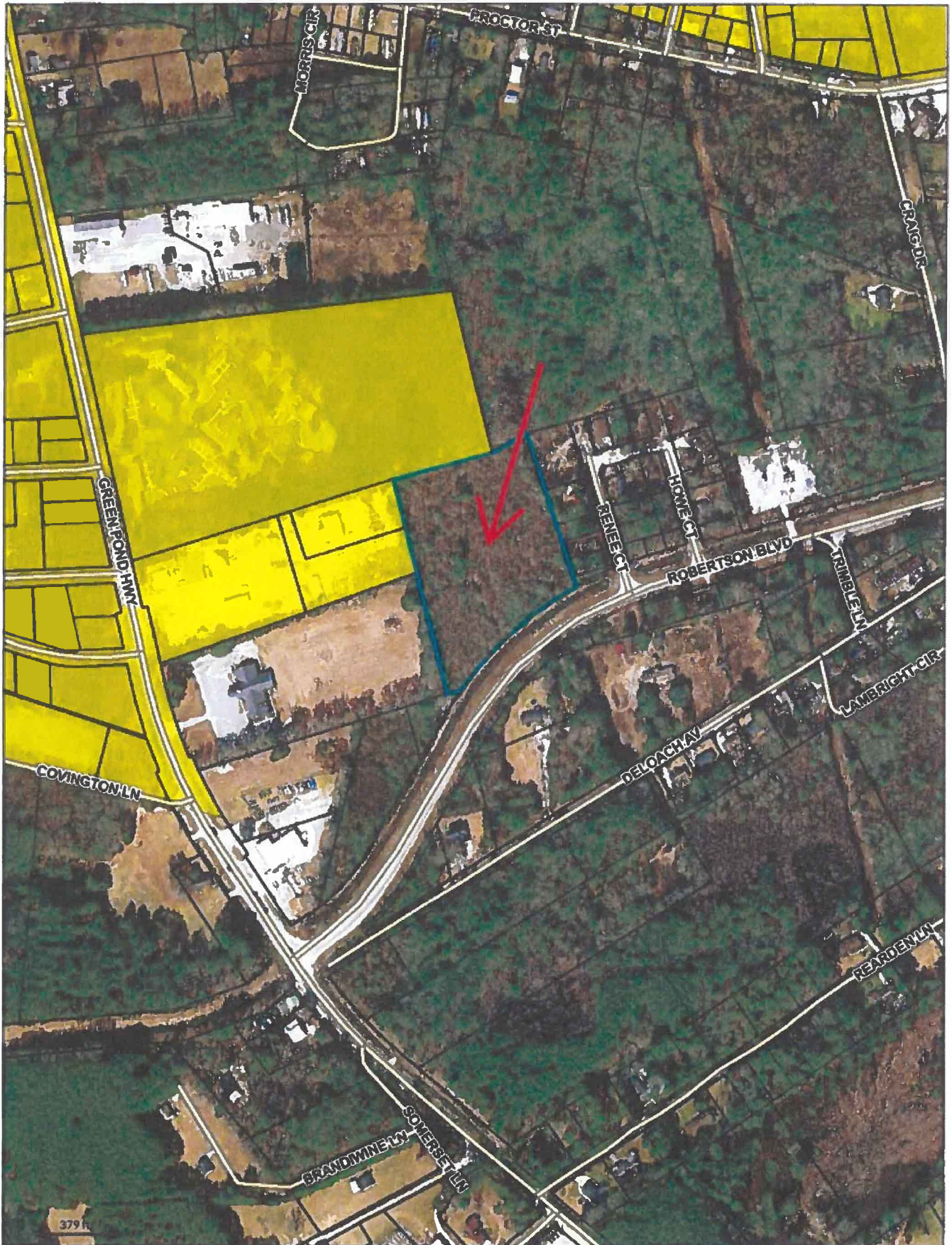

Staff recommends purchasing the backhoe loader from Blanchard Cat through the State Contract in the amount of **\$147,359.67**. The FY 2025-2026 Water Department budget estimated the cost of the backhoe at \$161,000.00. City staff asks for Council's favorable consideration of this request. Regarding the quotes submitted for the purchase of two police interceptor vehicles, below are the parameters for the local preference option.

Sec. 2-251. - Local preference option.

- (a) This option allows the lowest local bidder (defined as a bidder whose business is physically located and operating within the limits of the City of Walterboro or Colleton County) to match the bid submitted by the non-local low bidder if they are within a set percentage and thereby be awarded the contract.
- (b) Whenever the purchasing agent purchases services, supplies, materials, and/or equipment for the City through the use of competitive process, including quotes, bids and proposals, a percentage preference shall be used for evaluation purposes, according to the categories as set forth herein. When bid submissions are evaluated, a percentage from the local preference classification shall be deducted from the total dollar amount bid by local vendors on competitive quotes and bids, and from the total evaluated aggregate score obtained by local vendors on proposals. The total amount of local preference granted in a single bid shall not exceed an amount determined as set forth herein over a non-local vendor. The award shall be made at the price of the lowest quote, bid or proposal. If the lowest bidder after application of the local bidder preference is the local bidder, then that bidder shall have the option to match the lowest quote, bid or proposal. In the case of an absolute tie, an award will be made to the local vendor. In the case of a tie between local vendors, the award will be determined by lot.

When applying this calculation to the bid submitted by Cooper Chevrolet, the local vendor does have the option to match the lowest quote.

The Event

FestiVELO is thrilled to continue its partnership with the City of Walterboro to host one of the most unique events in the United States. This year's event will occur from November 5th to 9th, featuring short, medium, and long rides each day. We are honored to be part of the team providing these four days of cycling, festival activities, friendship, food, and fellowship to 300-350 cyclists and their families traveling from over twenty states.

It all begins at the event headquarters: the Colleton Museum and Farmers Market. During the four and a half days of FestiVELO, this venue showcases Walterboro's hospitality while celebrating its rich history. Throughout the weekend, tourists and their families can often be seen milling around the Farmers Market, exploring the exhibits and appreciating the past.

The food itself attracts many people to FestiVELO. Over the years, we have developed a close relationship with Eartha Cunningham from the Colleton County Commercial Kitchen and the Colleton County Feeding Program. This also includes coordinating food provision at rest stops along the route, creating a continuous opportunity for them to gain experience in pursuing their mission of commercial food planning, preparation, and service. Eartha and her team work diligently to provide three meals and snacks daily for cyclists and their families. We estimate that for every three registered cyclists, at least one family member will join us during meals and stops.

Additionally, because we highly value our relationship with the city, we promote and encourage attendance at the City's First Thursday festival by limiting our FestiVELO activities on Thursday nights. We hope attendees will discover more of Walterboro's unique charm by engaging with the locals.

In preparation for and during the event, we prioritize and encourage cyclists and their families to adopt a "local first" approach. For example, we collaborate with local t-shirt suppliers, printers, and other vendors whenever possible. During the event, when we need materials and supplies, we shop locally before turning to larger market areas. We are committed to supporting the community that consistently supports us.

The area covered by a 100-mile cycling route is extensive, providing the opportunity to engage a much larger community. FestiVELO community volunteers, supported by event leadership, continuously monitor the riders and the course to ensure assistance is always nearby. Support and Gear (SAG) volunteers provide on-course monitoring while tourists navigate the route. Rest and nutritional stops (churches, community centers, vacant lots, etc.) are staffed and located approximately every 15 miles. From Thursday through Sunday, in various parts of the city and county, out-of-towners and locals become integrated as they all move around.

After a day of riding and festivities, everyone enjoys the FestiVELO activities at the Farmers Market or the offerings of Walterboro. They then return to one of the hotels, tent sites, or RV centers to get up early the next morning for another day of adventure with us.

The Leadership

FestiVELO is led by a skilled team that consists of the event director and the leadership board. Additionally, numerous volunteers generously dedicate their time and skills each year to ensure its success. With well over 100 years of cumulative event directing experience shared amongst its leaders, FestiVELO is in great hands. Organizing and executing an event of this scale is no small feat, and our team performs exceptionally well and consistently each year.

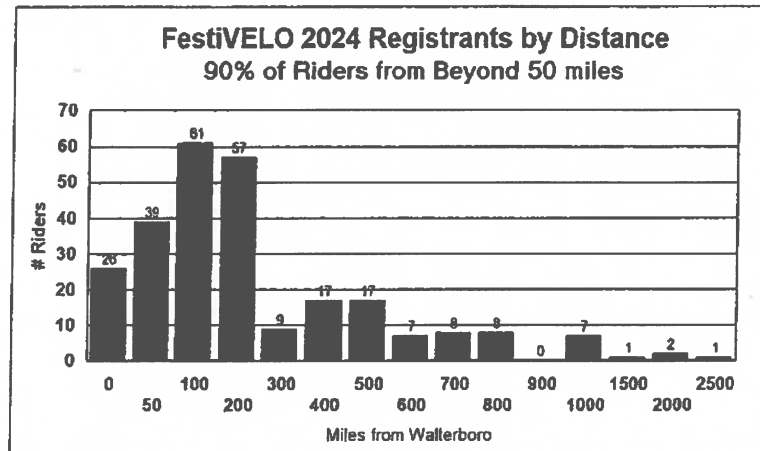
A truly unique feature of FestiVELO is our custom-designed FestiVELO App, which is essential for managing the ride. Integrated with the website and registration system, volunteer ride managers use it to track ride logistics, volunteers, registrants, rest stops, rider locations, and routes through location services. The App enables remote coordination via phone, as it fully integrates three databases: RaceReach registration, our website routing, and RaceReach volunteer management. Widely utilized by riders and volunteers, the App has been downloaded over 1500 times since the development of the FestiVELO/Walterboro App in 2016. The following chart illustrates the increasing usage of the App.

These are just a few ways that FestiVELO annually collaborates with and showcases the City of Waterboro in offering this unique ride.

B. Benefit to Tourism

As with most cycling events in 2024, participation for the 2024 Edition of FestiVELO was below normal. Traditionally, FestiVELO draws between 400 and 500 participants from 18 to 25 states and several countries to Walterboro. This includes cyclists, volunteers, spouses, families, and significant others. Approximately 90% of registered cyclists come from more than 50 miles away from Walterboro.

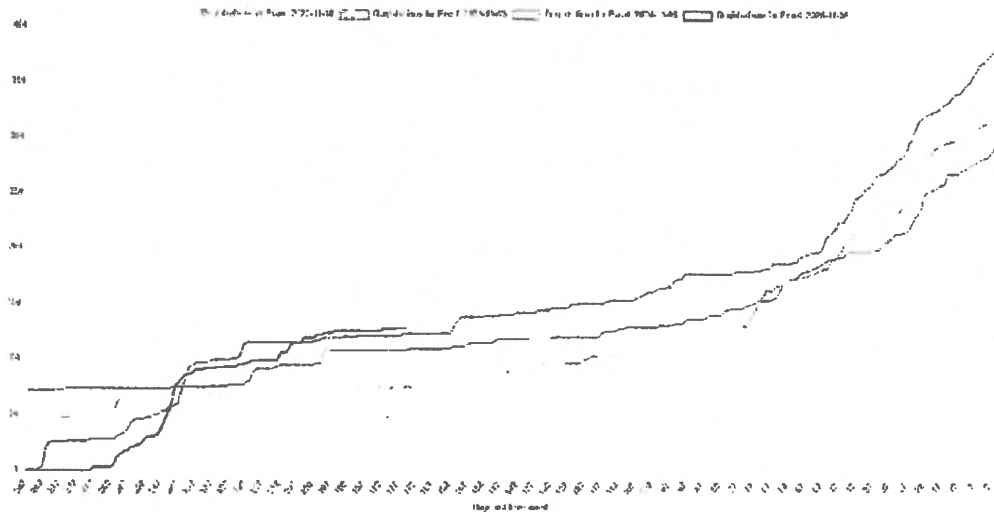


Despite having fewer attendees last year, we extrapolate from registration and survey data that participants utilized approximately 670 room nights. This figure includes bed and breakfasts, RV spots, and camping locations. Based on current registration trends, we expect that the numbers will return to a range of 900 nights.

Other strategies to boost exposure and attract visitors to Walterboro include collaborating with organized rides in SC, NC, VA, and MD. Additionally, the Event Guide published each year contains relevant information about attractions in and around Walterboro. This guide is often kept by cyclists as a reference for future trips to FestiVELO and Walterboro.

The combination of the FestiVELO website, app, event guide, and social media provides substantial and effective promotion for Walterboro. The annual marketing investment for

this ride yields positive results as we attract new participants who learn about us through these channels. The likelihood of these new riders positively impacting future tourism is high.

C. Benefit to Community

FestiVELO brings business to hotels, restaurants, shops, and stores that offer supplies and food. The Farmers Market, our previously mentioned HQ, also supports local, often homegrown small startup businesses and downtown shops, attracting hundreds of riders to the after-ride festivities. Additionally, the event creates a relaxed atmosphere for good-natured fun and fitness, providing positive experiences for both tourists and residents during the event.

Additionally, the event organizers come from South Carolina and North Carolina. They have a deep passion for the Lowcountry, which is evident in the unparalleled cultural engagement present at every SAG stop. This fosters a memorable connection among tourists, volunteers, and residents with Walterboro's churches, community centers, and local neighborhoods. The remarkable social atmosphere at the stops showcases the charm of Walterboro and offers an experience that keeps tourists coming back each year.

D. Tracking: Number of hotel/motel room nights projected to be added as a direct result of this project (Include brief explanation as to the calculation used for this estimate as well as description of how you plan to track this information).

Please refer to the overnight stay graph and data in section B above for hotel and motel room nights. Based on the previously mentioned 2025 registration trends, we estimate that approximately 900 hotel, BNB, Airbnb, and camping room nights will be utilized by participants. This estimate is based on a target of 330 to 350 cyclists, along with their guests, staying over a span of 2 to 5 days. Historically, most attendees stay 3 to 4 nights.

E. Duration of Project (Start and End dates)

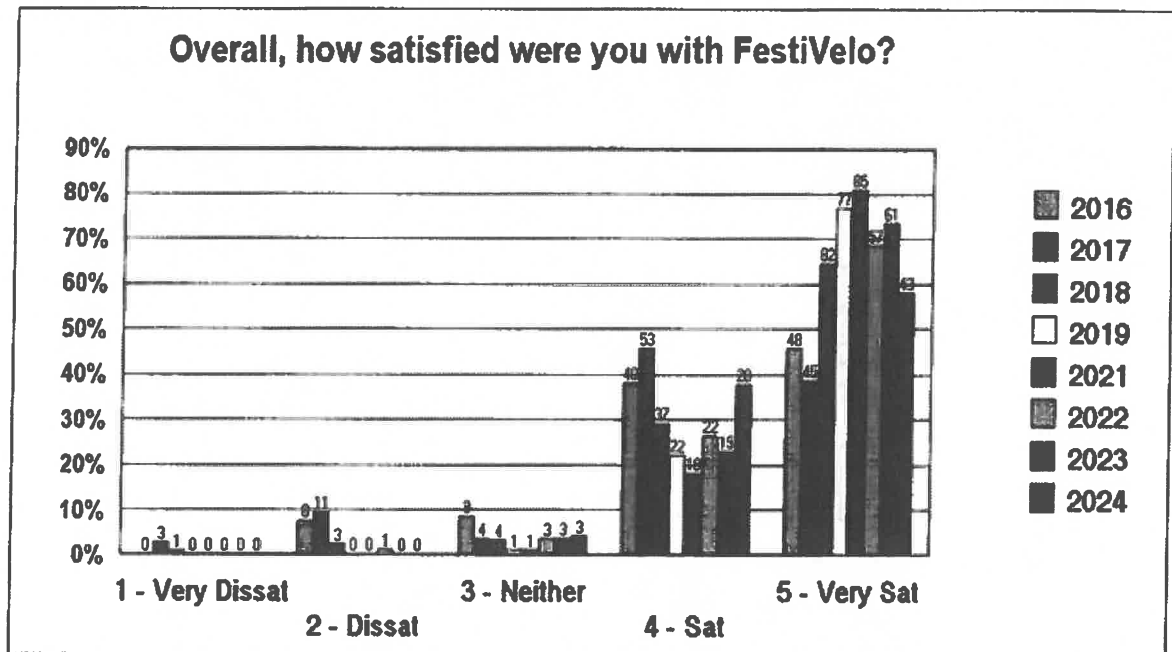
The event will take place from November 5 to 9, 2025. In preparation, many volunteers will arrive on November 4 and depart on November 10 or 11. Up to 30 event staff will be in Walterboro for 5 to 7 days.

Event organizers work together with local law enforcement, SCDOT, the fire department, and First Baptist Church/City of Walterboro to coordinate the tent camping location.

G. Additional comments

The Walterboro/FestiVELO partnership has made Walterboro a "Home away from home" for participants and tourists. As mentioned earlier, many return each year. Throughout the year, we receive notes from individuals who have vacationed in Walterboro because of their experience with us. Our annual survey reflects the high level of satisfaction. II. Narrative

The South Carolina Artisans Center is the largest single tourist attraction located in Walterboro. It was officially designated the "Official Folk Art and Craft Center of South Carolina" by the governor in 2000. The Center was originally conceived as a rural economic tourism development project. It was determined early in the planning stages that this Center should have an economic impact upon the entire state and the project's planners proceeded to make that happen. The Center now showcases the work of over 200 artists from 36 out of 46 counties across the state.

A. General Project Description:

We are continuing our efforts in diversifying our marketing and advertising outreach in a comprehensive manner. We were again successful in obtaining a grant from The Evening Post Publishing Newspaper Group to expand our marketing efforts around the state through their extensive media brands. We are requesting \$20,000 to fund this comprehensive plan with The Evening Post which includes streaming, digital banner ads, and print ads from **July – December 2025**. We will target the state's regional and metro markets of the Lowcountry, Midlands, Pee Dee and Upstate through their media channels.

In our relationship with King & Columbus, a full-service marketing agency of the Evening Post Publishing Newspaper Group (this agency created our videos that was funded by ATAX funds), we are interested in engaging their services to position the Center as a cultural destination around the state and beyond. Those services would include: public relations and

media; paid and organic social media; and content creation. This campaign would target regional and metro markets that are a short drive distance to the Center; Bluffton/Hilton Head Island, Charleston, Columbia, Greenville/Spartanburg and Savannah, GA. We are requesting \$30,000 for these services and it would run from July - December 2025.

To round out our marketing promotions, we are interested in continuing partnering with South Carolina Parks, Recreation and Tourism (SPRT) and advertise at three (3) of their welcome centers. We have an opportunity to feature a 30-second video on a 3 X 3 video wall at the Dillon, Fort Mill, and Hardeeville Welcome Centers. The total estimated number of 0:30 spots delivered during a 12-month flight are 21,840 at each location. We are requesting \$15,000 to fund this annual opportunity from July 2025 - June 2026.

B. & C. Benefit to Tourism and/or Community:

We have become a major Tourist Destination off I-95. Approximately 426,000 people have visited the Center over the past thirty (30) years. Over 95% of the Center's customers have traveled from outside of Colleton County and over 85% are visitors from another state. The majority of our customers have taken time from their traveling to stop in Walterboro, shop at the Center and enjoy our exhibits. They are also looking for other places in Walterboro to shop and dine. The City of Walterboro has made downtown a wonderful place to send our visitors.

The South Carolina Artisans Center is the only Tourist Attraction/Retail Venue in the Walterboro area that is open for business 6 days a week.

The South Carolina Artisans Center has consistently pursued all avenues of advertising and marketing including *Facebook and Instagram* pages and on our website www.scartisanscenter.com.

D. Tracking:

This marketing and advertising campaign will utilize paid social media, Google ads, streaming ads, and print in the before mentioned regional markets. We will be provided monthly reports by the advertising agency to monitor the effectiveness of the campaign.

E. Duration of this project

The marketing campaign will be conducted from July - December 2025 and the Welcome Centers' video promotion will be conducted from July 2025 - June 2026.

Project/Event Description (narrative)

Washington Street Plaza/Veterans Memorial Park is approaching its 40th anniversary and is in critical need of renovation. The plaza was completed in 1985, with the Veterans Memorial added in 1989. The space serves as a central gathering space for both residents and visitors, featuring a prominent waterfall, mature landscaping, and open public areas.

This revitalization project will include the complete replacement of the internal plumbing system that operates the waterfall, installation of a decorative backsplash, new landscaping, the addition of benches, and the installation of public restroom facilities. These updates are

essential to preserving the integrity, functionality, and aesthetic appeal of the space and Downtown Walterboro.

The Walterboro Tourism Commission (WTC), an I.R.S. designated 501(c)(6) nonprofit organization, is a central tourism resource dedicated to increasing visibility of the tourism industry within the Walterboro area to attract crucial tourism related dollars and economic growth, as well as the development and promotion of Walterboro as a tourist destination.
